India's Women Health Campaign sets 3 Guinness World Records

New Delhi: India has achieved three Guinness World Records under the nationwide 'Swasth Nari, Sashakt Parivar Abhiyaan' (SNSPA), a campaign focused on preventive and women-centric healthcare. The records were set for the most people to register on a healthcare platform in one month, at over 3.21 crore, the most people to sign up for breast cancer screening online in one week, at over 9.94 lakh, and the most people to register for vital signs screening online in one week at the state level, at over 1.25 lakh.

Patna: As the electoral battle in Bihar intensifies, political parties continue to reach out to women voters but appear to have forgotten to give tickets to female candidates. In all, 258 women are contesting this election as against 2,357 male candidates. With 15 days left for the polls, women voters are being considered a key segment, particularly for the National Democratic Alliance (NDA).



Mallikarjun Kharge invokes Sardar Patel to demand ban on RSS, BJP Hits Back

New Delhi: Congress chief Mallikarjun Kharge has reiterated that the Rashtriya Swayamsevak Sangh (RSS) should be banned in the country, stating that even Sardar Vallabhbhai Patel had banned the participation of government employees in RSS's activities. The ban was lifted by the BJP government in 2024; it must be reinstated, he demanded.

"My personal opinion is that RSS should be banned," Kharge said at a press conference on Friday, comparing the RSS's ideology with "poison." The BJP has slammed the Congress for invoking Patel to attack the RSS after "ignoring" his contributions for decades. "Sardar Patel also said that one should not work for the RSS while in government service.

- Chittoor District 9th Additional Court delivers verdict - Accused shifted to Kadapa District Jail



From Our Staff Reporter Chittoor, October 31: The court has delivered a sensational verdict in the murder case of former Chittoor city mayor Katari Anuradha and her husband Katari Mohan. The Chittoor District Court, which found the five guilty, has given its verdict finalizing the death sentence for them. It is known that on November 17, 2015, the mayor and her husband Katari Mohan were murdered in the mayor's chamber. The Chittoor District 9th Additional District Court has confirmed the death sentence to Mayor Katari Anuradha and his wife, who had created a sensation in the state almost ten years ago, after the facts were proved that their son-in-law, Sriram achandra sekhar alias Chintu, who was registered as A1 in the case, had killed them along with four

others. In fact, on November 17, 2015, the then first mayor of the city, Katari Anuradha, and her husband Katari Mohan, who were in their chambers in the Chittoor Municipal Corporation office, were suddenly entered by their son-in-law Chintu wearing a burqa used by Muslim women. In this incident that took place in the blink of an eye, Chintu first shot his mother-in-law Katari Anuradha on the forehead with a pistol at point blank range, causing her to collapse and die on the spot. Later, upon hearing the gunshots, the mayor's husband Katari Mohan, who had reached the mayor's chamber, was attacked with knives by Chintu and his followers. Katari Mohan was seriously injured. Thinking that the mayor and his wife had been killed, Chintu and his followers also attempted to kill her follow-



ers near the mayor's chamber. Realizing the incident, the followers of the mayor and his wife fled the municipal corporation office with their lives in their hands. However, the mayor's husband Katari Mohan, who was lying in a pool of blood after being attacked with a knife, was rushed to the Vellore CMC Hospital in a special vehicle for better treatment. He died the same day while receiving treatment there. After the murder, Chintu and his followers jumped down from the terrace of the municipal corporation office and fled in vehicles that were already parked and ready at the municipal office nearby. In this context, the murder of the mayor couple created a sensation across the state at that time. Upon receiving information about the murder of the mayor couple, the Chittoor town police reached the scene and based on the primary evidence collected, registered a case against Chintu and 22 other people under various sections and investigated. Later, a few days later, the accused in the case were arrested and sent to remand. After the investigation of

the case began, Kasaram Ramesh of Srikalahasti, who was named as an accused in the case, was found not to be related to the case and was exempted from the case. Similarly, during the investigation of the case, a person named Srinivas, who was arrested on the grounds that he had serviced the pistol used to kill the mayor, died of illness. The investigation of witnesses in the case involving the remaining 21 people has been ongoing since 2022. In this context, on the 26th of this month, the court found A1

Chandrasekhar alias Chintu, Venkatachapalathi, A3 Jayaprakash Reddy, A4 Manjunath, and A5 Venkatesh guilty of the crime. With this, the case against the remaining 16 people in the case was dismissed on the same day. However, the final hearing was held again on Thursday and Friday against the five convicts whose crime was proven. In this sequence, as the evidence was strong, the court sentenced the five accused who faced the final hearing and Judge Dr. K Srinivasa Rao delivered the verdict at 10.55 am on

people belonging to the Chintu and Kathari communities reached the court in large numbers. In this sequence, there was some tension in front of the district court. However, as the Chittoor town police had made tight security arrangements, no untoward incidents took place. After the court verdict, the convicts who were sentenced to death were taken to the Kadapa District Jail. On this occasion, Katari Hemalatha, daughter-in-law of the late mayor and his wife, former mayor of the city and current chairperson of Chittoor Urban Development Authority (CHUDA), told reporters that justice has finally prevailed in the murder case of her inlaws and the respect of the Chittoor court has also increased with the death sentence to the convicts. He said that this verdict will surely disturb those who want to commit murders in the same order. Meanwhile, Public Prosecutor Shailaja on behalf of the prosecution and prominent High Court advocate Vijayachandra Reddy on behalf of the convicts pre-

sented their arguments.

New water in Bihar politics

In the 1970s, Lok Nayak Jayaprakash Narayan stirred a new spirit of change among the youth of the country, which completely transformed national politics. Not only was the Congress party, which had dominated national politics until then, gradually shrinking, but for the first time, non-Congress governments were being formed not only at the Centre but also in many large states. The youth movement that started in Bihar also brought about new leadership in almost all political parties. However, since then, Bihar politics, especially in the last 35 years, has been limited to just two leaders. There were situations where no one could form a government there without either Lalu Prasad Yadav or Nitish Kumar. Especially for the past 20 years, Bihar politics has been changing in such a way that no matter who wins the elections, it is Nitish who forms the government. The current assembly election campaign pattern reveals that Bihar is now on the path towards political change for the first time. Lalu Prasad has already distanced himself from electoral politics. This is also likely to be the last election for Nitish Kumar. He does not seem to be as confident as before. He came to power in 2005 with the slogan of liberating Bihar from the Lalu Prasad family, which was branded as 'Jungle Raj'. He is known for providing facilities like law and order, protection for women, arresting criminals, primary education and health. Perhaps he is the leader who has been in politics for a long time with the support of women voters across the country. The 2020 Bihar elections were a close contest. The NDA defeated the Mahaghatbandhan by a margin of just .03% of votes. Last year's Lok Sabha elections were also unsatisfactory for the NDA. That is why interest in the current assembly elections will increase. For this reason, the BJP will not dare to push Nitish Kumar aside like in the past. In the past, they tried unsuccessfully to restrain Nitish by using Ram Vilas Paswan during the LK Advani regime and Chirag Paswan during the Modi regime. For the first time, a young leadership is competing for supremacy in Bihar. People like Tejaswi Yadav, Chirag Paswan, Mukesh Sawhney or Prashant Kishor are trying to influence Bihar politics. The India Alliance has already announced Tejaswi Yadav as its chief ministerial candidate. On the other hand, Tejaswi has announced Mukesh Sawhney as its deputy chief minister. The BJP, which does not have a leader with its own public appeal in Bihar politics, is promoting Chirag Paswan. At one stage, he tried to become the chief ministerial candidate. His party was allotted 29 seats beyond his strength. Now, Prashant Kishor, who has served many parties as an election strategist until recently, is entering the electoral arena himself. He has tried to make a strong impression on the people through padayatra for two years. He said that he is relying on the 'wind' that if his party wins, it will get

150 seats, otherwise it will get only less than 10 seats. In a way, the 'Voter Adhikar Yatra' led by Rahul Gandhi two months before the elections received a remarkable response. There were signs that there was serious opposition among the people towards the Nitish Kumar government and that people wanted a change. The Congress, along with its India alliance partners, took part in this yatra with the aim of consolidating support, and all the top leaders of the alliance, including Tejaswi Yadav, Akhilesh Yadav and MK Stalin, participated in it. However, even after the election schedule was announced, Rahul Gandhi did not look at Bihar for two months. On the other hand, the opposition alliance was stuck in the seat adjustment. They could not officially announce the seat adjustments. However, by announcing Tejaswi Yadav as the chief ministerial candidate, the NDA alliance was put on self-defense. Many believe that the BJP is taking strategic steps towards leaving Nitish Kumar after the elections and forming a government on its own by promoting Chirag Paswan. A few days ago, Union Home Minister Amit Shah had said that the NDA MLAs would choose the chief ministerial candidate after the elections, while saying that they would go to the polls under the leadership of Nitish Kumar. However, when the opposition alliance announced Tejashwi Yadav as the chief ministerial candidate, the BJP, which was in self-defense, had to name Nitish as the future chief minister. The next day, Prime Minister Narendra Modi tried to clarify this issue during his visit to Bihar. However, there is strong opposition within the BJP ranks to Nitish Kumar continuing as the chief minister. They are insistent that their party leader should become the chief minister. Similarly, there is no positivity towards the BJP even within the JDU ranks. It remains to be seen to what extent the exchange of votes between the respective parties will continue properly in such circumstances. However, the strengths of the parties in Bihar are based on caste. Several surveys indicate that 57 percent of people vote based on caste, not party or candidate. By announcing Mukesh Sawhney as the Deputy Chief Minister, it is clear that Tejaswi is trying to undermine the BJP's support among the most backward communities. The law and order situation has become worrisome for some time under Nitish's rule, the selection of candidates has led to confusion even in the two main alliances, and a new generation of voters who are unaware of the 'jungle raj' (rule of the Lalu family) being promoted by the BJP are becoming crucial in the current elections. In fact, Prime Minister Modi has been working hard to gain a foothold in Bihar since 2014. Many new projects related to infrastructure have been taken up. However, due to the lack of strong leadership, the BJP is not able to gain a strong foothold in Bihar. Efforts have been made to strengthen the BJP without Nitish. However, since such efforts have not yielded results, there are now situations where it is inevitable to go to the elections under the leadership of Nitish. The question now arises as to what impact Prashant Kishor will have in these elections. Kishor was among the few who first understood the electoral chaos in the country. Now even as a leader, he has built a party in a very short time. So much so that he has now fielded candidates in 243 constituencies. However, it is alleged that the BJP forced three of Jan Suraj's candidates to withdraw. Once upon a time, politicians used musclemen to come to power. Later, many musclemen themselves became politicians. Similarly, some businessmen who fund politicians have also started entering the political arena to directly influence policies. Then why can't an election strategist become a politician? He started his own party thinking.

Recalling Mumbai's Last Hostage Situation From 2008 - When A Gunman Took Over A Bus

2008 may easily qualify as India's blood-soaked year. Many big cities like Jaipur, Bangalore, Ahmedabad, New Delhi and Guwahati were rocked by serial bombings, killing hundreds and maiming thousands. However, Mumbai remained peaceful. After the train blasts of July 2006, no further terrorism-related incidents were reported in Mumbai. Although the Indian Mujahideen, which confessed to many blasts across the nation, had links in Mumbai, the city remained untouched by their diabolical designs. The popular Bollywood song, 'Ye Bambai shehar haadson ka shehar hai', charges Bombay to be a city of tragedies. True to its claim, Mumbai couldn't sustain peace for long. After a lull of an initial few months, a wave of fear and anxiety hit the common dwellers of Mumbai. On October 27, 2008, at around 10:30 am, the news trickled in that a double-decker BEST bus numbered 332 had been hijacked at Kurla. As per the initial information, 12 passengers were taken hostage and one was shot. My immediate apprehension was that after conducting bloodbaths across India, the Indian Mujahideen was now back in Mumbai. I got a call from a source in the local police that the hijacker wanted to talk to the media. I hurriedly left for the

spot, which was 14 kilometres away. My colleague Umesh Kumawat was on another shoot, and he rushed towards

I was thrilled with the thought of acting as a hostage negotiator. In my mind, I began preparing on how I should convince the hijacker to release the hostages and surrender. It would be a great learning experience, I thought. However, by the time I reached Kurla, negotiating a traffic jam, everything was over. The hostages were rescued, the area around the bus was cordoned off, the hijacker was killed, and his body was being taken to the hospital. I saw ACP Mohammed Javed standing near the bus, still holding the emptied service revolver in his hand. It was Javed who had first fired on the hijacker and led the police team inside the bus. 'When I entered the bus, I saw him holding a passenger and pointing the gun towards him. I told him to surrender, but he didn't. What should have I done to save that passenger's life? I had to fire,' Javed explained to me. Javed and his team fired over a dozen bullets at the hijacker, of which three pierced his head and one ripped his heart.

The hijacker turned out to be 25-year-old Kundan Singh, aka Rahul Raj, from Patna in Bihar. He was instigated by the hate

campaign against North Indians launched by the MNS chief Raj Thackeray. That year, after Raj Thackeray was arrested on charges of giving provocative speeches, his party workers attacked the North Indians. A few people were lynched by violent mobs. North Indian youngsters, who came to Mumbai to appear in a railway recruitment exam, were thrashed. An enraged Rahul Raj reached Mumbai with a country-made pistol and boarded the BEST bus at Sakinaka. As the bus reached Kurla, he took control of the

hostages. Seeing police approach the bus, he started firing randomly, and one bullet hit a passenger. The people around heard him shouting from the window that he didn't intend to harm the passengers but wanted to kill Raj Thackeray.

The encounter ensued a controversy, and a bitter war of words followed between the politicians of Bihar and Maharashtra. Bihari politicians across the party lines condemned the encounter and alleged that no efforts were made by the Mumbai Police to catch Rahul Raj alive. The Maharashtra government retorted by saying that the police did the right things as per the circumstances. Apart from a chief secretary-level enquiry announced by the Maharashtra government, the doors of the Supreme Court and Patna High Court were also knocked by the petitioners. Although the bus hijacking incident made the citizens of Mumbai fearful, especially those using public transport, it was a minor incident when compared with what the city had endured in the past. At the time, Mumbaikars didn't know that exactly after a month, something was going to happen in their city, which would shake the world.

It has been quite a week in the Supreme Court. The Union Government's petition against the Calcutta High Court's ruling on the Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA) was dismissed. The High Court had directed that the 100-day work scheme be restarted in the state from August 1, 2025. This has vindicated what the State has been saying for over three years, that the Centre's denial of dues was political, punitive, and unlawful. That same day, another bench reprimanded the Delhi Police for asking for more time in the Delhi riots bail case, where student activists such as Umar Khalid and Sharjeel Imam, Meeran Haider, Gulfisha Fatima and Shifa Ur Rehman have spent over five years behind bars without trial. Both hearings showed the Court pushing back against long delays and executive overreach. Parliament's understanding of the same issues seems to be moving in the opposite direction. A new bill proposing automatic removal of ministers who spend more than 30 days in custody was introduced in the Lok Sabha in August 2025. This bill claims to promote accountability. However, on close inspection, it undermines the presumption of innocence, destabilises governance, and entrenches inequality. Far from strengthening democracy, it risks weaponising arrests as political tools. It overrides the electorate's will without a judicial conviction and opens a door to political abuse that our Constitution was designed to protect its citizens from.

The Dangerous Shift: Arrest as Guilt

Indian criminal jurisprudence talks about one fundamental principle: innocent until proven guilty. This bill flips that principle on its head by imposing a penalty, loss of office, based solely on arrest and detention. It bypasses trial and conviction entirely. That is precisely the kind of arbitrariness Article 21 forbids. Yet, the bill treats detention as de facto conviction.

This bill, by equating arrest with guilt, overrides the electorate's mandate, weakens separation of powers, destabilises governance, and promotes inequality.

The Supreme Court in its past rulings has emphasised that removal from office must follow due process, not mere allegations. The proposed bill shortcircuits this safeguard, imposing a penalty without trial, conviction, or judicial determination of guilt. India's prison population is overwhelmingly made up of undertrials, constituting 75% of the total prison population.

Interestingly, since 2014, at least 12 sitting opposition ministers have been arrested; nine of them from non-Bharatiya Janata Party (BJP)-ruled states. Eight crossed the 30-day custody mark. Under the bill, they would have been automatically stripped of office despite never being convicted.

Why 30 Days?

The bill never explains the 30-day threshold. Pre-trial custody can, and frequently does, extend beyond 30 days because of routine procedural delays. Even under the Bharatiya Nagarik Suraksha Sanhita (BNSS), default bail is set at 60/90 days; the bill's 30days requirement has no procedural anchor. By tying ministerial survival to such an arbitrary threshold, the law risks disqualifying leaders before their trials even begin. The bill seems to replace the principle of 'innocent until proven guilty' with 'jobless until granted bail'.

Separation of Powers

The Constitution separates political accountability from judicial and executive actions. Removal from office is fundamentally a political question, settled either by legislatures or by the electorate. The bill collapses this boundary, allowing arrest, an executive act subject to police discretion and judicial oversight, to directly determine political tenure. This dangerously blurs the line between branches of government, inviting misuse.

Unequal Treatment and Disproportionate Impact on Marginalised Groups

The bill also introduces glaring inequities. Under the Representation of the People Act, 1951, MPs and MLAs are disqualified only upon conviction, not upon arrest. This bill creates a two-tier system in viola-



tion of Article 14's guarantee of equality before the law for specific ministers. National Crime Records Bureau (NCRB) data reveals that undertrials are disproportionately drawn from marginalised communities: Around 21% are Scheduled Castes (SC), 9% Scheduled Tribes (ST), 36% Other Backward Classes (OBC), and roughly 19-21% are Muslims. Together, marginalised groups (SC/ST/OBC/Muslims) represent over 85% of undertrials.

Destabilising Governance Consider the consequences if a Prime Minister or Chief Minister is arrested, even briefly. Governance could grind to a halt, destabilising elected governments on the basis of unproven allegations.

Chilling Effect on Opposi-

Finally, the bill creates a chilling effect. If arrests, regardless of conviction, mean automatic loss of office, opposition leaders may think twice before challenging the government. In a democracy where dissent is vital, such a deterrent undermines the foundation of electoral choice. Accountability in politics must be rooted in conviction, not custody. Otherwise, democracy itself risks becoming captive to the whims of arrest.

NDA's Manifesto On Bihar Elections Is Evasive, Full Of Vague Promises

Shrewdness is all that reflects NDA's manifesto on Bihar elections released on October 31, 2025, just a week before the first phase of election to be held on November 6. It is elusive. It does say nothing about the plight of Bihar, even though it is the third most populous state after Uttar Pradesh and Maharashtra, ranking at the bottom in almost all indicators of development. Nevertheless, the document vaguely promises a "Developed Bihar" under NDA, while evading specifics, as if intentionally, so that people can't hold them guilty for broken promises. Perhaps, NDA has nothing to say in respect of the current plight of the state and its people, since it is contesting under the leadership of the same CM Nithish Kumar, who has been ruling the state for the last two decades since 2005. BJP leaders have been shrewd enough not to announce Nitish Kumar as CM face of NDA, but at the same time they have been saying that

their alliance is contesting under his leadership, while they themselves calling the shots with a whispering campaign by the RSS-BJP rank and file that CM will be changed if they will come to power. Sugar quoted words are strewn in the entire NDA manifesto, most of them are without specifics. Most of the promises are vague since they don't reveal how much time they will take to make the promise a reality, and how it will be realized, such as the promise "For a Developed Bihar", the first and foremost promise and the subtitle of the document.

As everyone in Bihar, NDA too is aware of the anti-establishment sentiment prevailing among the youth of the state on account of joblessness among them. No wonder, NDA manifesto gives the first guarantee to youth. "Guarantee to golden future for every youth," it says. To every youth, a job and employment. It promises 1 crore+ government jobs and

employment, to conduct a Skill Census and skill-based employment, and to establish Bihar as a Global Skilling Hub through Mega Skill Centres in every district. However, there is not timeframe mentioned for all these things. Women's have been seen playing significant role in deciding the fate of the political parties in the country in recent times.

This trend has been most prominent in the recently held elections across the country, including Haryana, Delhi, Maharashtra, and Jharkhand. Women's of Bihar has also been playing significant role. CM Nitish Kumar hopes that he will get majority of women's votes because of his certain policies, such as ban on liquor to the more recent CM Women's Employment Scheme, launched just before the election. The manifesto promises Empowerment of women and making them rich and through them and Developed Bihar.
