"Army Has No Religion, Caste"

: Rajnath Singh snaps back at Rahul Gandhi



New Delhi: Rahul Gandhi's remarks about '10 per cent of India controlling the Army' was slammed by Rajnath Singh Wednesday. The Defence Minister accused the Congress MP of trying to divide the armed forces and said firmly that "the Army has no religion or caste".

Campaigning in Bihar, before voting tomorrow in the first phase of the Assembly election, Singh said, "Rahul Gandhi is trying to

Singh hit out at Gandhi for trying to 'drag the Army into politics' and criticised him for comments that have been seen as pushing for quotas for different communities within the armed forces. "There should be a reservation. We (i.e., the ruling Bharatiya Janata Party) are supporters of reservations... we have given to the poor. But the Army?

Mamdani, who is also the youngest to hold the office of New York City mayor, also stated that his victory toppled a political dynasty. "Standing before you, I think of the words of Jawaharlal Nehru - a moment comes, but rarely in history, when we step out from the old to the new, when an age ends and when the soul of a nation long suppressed finds utterance. Tonight, we have stepped out from the old into the new," he said in his victory speech.

The focus in Bihar is on women's votes

While the state of Bihar has been reeling under unemployment for several years, the promises made by leaders and parties during the election campaign are not providing any relief to the unemployed youth. The ruling and opposition parties, who are not paying much attention to this issue, are announcing attractive schemes to loot the women's vote bank. In these circumstances, the question is to what extent women's votes will determine the victory. Immediately after the Election Commission announced the dates for the Bihar Assembly elections, Chief Minister Nitish Kumar transferred a total of Rs. 2100 crores to be deposited directly into the bank accounts of 21 lakh women in the state. This is to provide financial assistance of Rs. 10,000 to each woman voter under the Chief Minister's Mahila Rozgar Yojana. This scheme was launched by Prime Minister Modi at the end of last September. In response, the opposition RJD has promised Rs. 10,000 per month to every woman belonging to the economically weaker and backward classes if they vote for their government to come to power. It is noteworthy that the promise to implement the 'Mai Bahin Maan Yojana' scheme to provide financial assistance of Rs. 2500 is announced.

These two big announcements demonstrate their unwavering commitment to the women of Bihar. In a state steeped in casteism and patriarchy, it is very strange to see women as independent. It is not surprising that every constituency is divided into two. Since 2014, special efforts have been made to win the vote bank with women as the center. This does not mean that women's votes alone determine the chances of victory. Women in Bihar do not even have the freedom to choose their candidate and vote. Nitish Kumar has been running women-centric politics with schemes to attract women since he first became the Chief Minister in 2005. As a result, women voters turned out for the first time in Bihar's history in the 2010 assembly elections. While women voted 54.5%, men voted only 51.1%. This gap was bridged nationally in the 2019 elections. However, it is worth noting that, strangely enough, 16 lakh women voters out of the 47 lakh voters who were not included in the final list of voters in the Special Comprehensive Revision (SIR) this time are missing.

All of them are EBCs and Dalits. Meanwhile, the caste survey conducted by the Bihar government in 2023 has changed political attitudes forever. In fact, no party needs the exact numerical strength of the respective caste groups to decide the candidates to contest the elections. But if we look at the facts that are being revealed, some estimates are coming to the fore. Among the backward classes, the Economically Backward Classes (EBCs) constitute 36 percent of the population, while the Other Backward Classes (OBCs) constitute up to 60%. In this, an adjustment must be made for the 'elders'. If we look at the EBCs, Mukesh Sahni of Vikassheel Insan (VSIP) K became a must for the post of Deputy CM in the 'Maha Ghatbandhan (MGB). Although he was denied before the caste survey in 2020, he had to be given it later. Based on this, it seems that the decisions of the EBC and OBC communities will play a key role in these elections. The determination to get their seats no matter which government comes is prominent among the EBC and OBC communities. EBC candidate Nitish Kumar in the NDA has been making welfare his priority since he became the Chief Minister in 2005. The NDA will have to realize the popularity of JDU. Despite having to show loyalty to Nitish, the unemployment problem seems to be a serious hindrance. Youth are waiting for government jobs. But paper leaks in the exams conducted for job selection, chaotic conduct of exams, corruption, and delay in notifications are all demoralizing the youth. Recruitment in key government departments has stopped. As a result of exam paper leaks in the first half of 2024 and 2025, recruitment in many government departments including Police, Staff Selection, Revenue has stopped. Now that elections are underway, the delays in these recruitments have increased the disaffection and protest of many young job seekers, who consider them to be government betrayal. Despite frequent government advertisements, many jobs remain informal and unstable. According to the Periodic Labor Force Survey, the unemployment rate in Bihar is over 5%. But labor participation, the proportion of people actually working or waiting for work, is the lowest in the country. Only 28 out of 100 youth between the ages of 15 and 29 are employed. The same number is much smaller among women. The unemployment problem is contributing to the increase in youth depression in villages and cities.

The Rich Get Fit, And Poor Get 'Lectures' - That's India's Ozempic Problem

India stands on the brink of a metabolic crisis. Nearly ninety million adults, about 10.5% of those aged between 20 and 79, live with diabetes, making ours the world's second-largest diabetic population after China. Obesity, the silent precursor, now afflicts nearly a quarter of Indian adults, while abdominal obesity exceeds 40% among women. Together, these conditions fuel a rising tide of heart disease, stroke, and kidney failure that steadily undermines our public health foundations. Into this landscape arrives Ozempic - Novo Nordisk's semaglutide injection - approved by the Central Drugs Standard Control Organisation (CDSCO) in September 2025 for adults with type-2 diabetes inadequately controlled by diet and exercise. Expected to launch by December and priced between ?10,000 and ?20,000 a month, it promises not only superior blood sugar control and weight reduction but also cardiovascular protec-

Ozempic Is An Achievement

Crucially, semaglutide exists because companies were free to invest, take risks, and profit from success. It is the outcome of decades of research and innovation - not a product of government decree. We should celebrate, not penalise, the profit motive that drives such progress. Innovation flourishes only when regulation is predictable, approvals are swift, and intellectual property is respected. India's drug bureaucracy, however, often moves at a glacial pace; simplifying approvals, incentivising voluntary licensing, and ensuring transparency would do far more for patients than any heavy-handed price cap ever could. Like any potent therapy, Ozempic carries risks. Nearly 40% of users experience gastrointestinal discomfort - nausea, vomiting, or diarrhoea sometimes severe enough to discontinue treatment. Rarer complications such as pancreatitis, gallbladder disease, or acute kidney injury have been reported, and the black-box warning about thyroid C-cell tumours prohibits use in those with a family history of such cancers. Emerging evidence suggests that up to 40% of lost through semaglutide may be lean muscle mass rather than fat, while prolonged appetite sup-

pression can cause nutritional deficiencies or worsen diabetic retinopathy. Yet, these are not reasons to retreat from progress. Adults deserve the liberty to make informed decisions about their own bodies. The state's duty is not to moralise about "weight-loss vanity" but to ensure accurate labelling, access to safety data, and education about risks. Responsible prescribing, gradual dose titration, and medical supervision must be encouraged, but through professional ethics and patient education - not bureaucratic suspicion.

When Regulation Goes

The rise of a grey market in India, where unsupervised doses are sold at exorbitant rates, demonstrates that excessive control merely drives patients underground. Regulation should protect safety, not police choice. Without a balanced approach, we risk replacing one epidemic - obesity - with another: weakness and malnutri-

The economics, however, expose the sharper moral fault lines. At a cost exceeding ?10,000 a month, Ozempic remains far beyond the reach of most Indians. Insulin, by contrast, costs barely ?300 a vial, and 80% of diabetics rely on overstretched public health systems. Ayushman Bharat, India's flagship insurance scheme, does not cover highcost injectables, while private insurers limit reimbursement to wealthier clients. Eli Lilly's tirzepatide (Mounjaro), priced even higher between ?14,000 and ?27,000, is already available in elite pharmacies. A vanity market is emerging in India's metros, where celebrities and affluent professionals use these drugs for cosmetic transformation while rural diabetics struggle to afford essential insulin. If life-saving medicines like Ozempic are to become accessible to ordinary Indians, it will require not bureaucratic diktats but market creativity supported by fair and predictable rules.

Learn From The World

Around the world, marketbased approaches have expanded access without price caps. In the United States, patient-assistance programmes and tiered pricing reduced costs for low-income users; Brazil's Farmácia Popular model used public-private partnerships to offer discounted generics; and Kenya's M-TIBA platform enabled families to prepay for diabetes care through mobile wallets. India can adopt such models - combining tiered pricing, digital health platforms, micro-insurance, and employer wellness plans - to extend access efficiently and sustainably. The state's role must remain limited yet firm: to prevent patent abuse, cartelisation, and anticompetitive hoarding, as US and European regulators have done against evergreening in oncology and HIV drugs. Patents should reward innovation, not perpetuate monopoly rents long after their social purpose is served. True accessibility will emerge not just from price ceilings or compulsory licences, which often deter innovation and reduce supply, but from open competition. India's experience with HIV drugs in the 1990s proves this: liberalising generic production, rather than imposing state control, drove prices down by nearly 90% and saved millions of lives across the developing world. The same opportunity now awaits GLP-1 therapies. Ozempic's patent expires in March 2026, and Indian pharmaceutical leaders like Dr. Reddy's, Sun Pharma, and Cipla are already preparing generic versions that could transform affordability. To realise this potential, the government must clear regulatory bottlenecks, fast-track biosimilar approvals, rationalise taxes on biopharma imports, and ensure patent clarity. The National Pharmaceutical Pricing Authority's reflex to control every rupee must give way to a

Entrepreneurs - fitness startups, healthfood producers, and wellness coaches - can do what ministries often cannot: make healthy living aspirational. Public policy should focus on enabling this ecosystem, through transparent labelling, fair competition, and better urban design that prioritises cycling lanes, walkable spaces, and community fitness, rather than micromanaging diets or imposing punitive taxes. India's 2026 bio-pharma roadmap, which promises incentives for local GLP-1 manufacturing, will succeed only if the state acts as facilitator, not manufacturer. Subsidies and public monopolies rarely deliver efficiency; what the industry needs is clear rules, low compliance costs, and open trade. The goal should not be patent races but affordable peptide production that can serve both domestic and global demand. If Indian firms such as Biocon, Dr. Reddy's, and Sun Pharma can produce high-quality semaglutide at scale, they could supply not only India but also emerging markets across Asia and Africa, reviving the promise of India as the pharmacy of the developing world. But to achieve this, India must resist its reflex to over-regulate. Every unnecessary form, every ambiguous guideline, adds cost that ultimately punishes patients.

The Class Divide Is Real Imagine tier-two and tierthree clinics dispensing generic semaglutide at ?3,000 a month, paired with nutrition counselling and fitness incentives under PM-JAY. Endocrinologists could act as gatekeepers against misuse, and Indian biosimilar innovators could once again demonstrate that affordability and innovation are not opposites but complements. Critics who dismiss Ozempic and its analogues as "lazy medicine" overlook the truth: for the fifty million Indians who fail oral therapy, semaglutide is not indulgence - it is salvation. Its cardiovascular protection rivals statins, and its potential to halve India's non-communicable disease burden - estimated at ?3 lakh crore annually - is immense. Yet, unless equitable access is ensured, this medical revolution risks deepening social divides, where metropolitan elites thrive, while the villages of Bihar, Jharkhand, and Odisha fade further into neglect. As Ozempic pens begin reaching Indian pharmacies, regulation must not lag behind enthusiasm. The government should mandate national registries to monitor long-term safety, expand pharmacovigilance to study how Indian genotypes respond, and integrate GLP-1 therapies into national diabetes guidelines. Training ASHA workers to improve adherence and funding public trials that combine GLP-1 therapy with traditional practices like yoga and dietetics could yield uniquely Indian models of care rooted in both science and culture.

The Mamdani Moment: A Political **Earthquake In America's Largest City**

p.m. on Tuesday, November 4, 2025, it took less than 40 minutes for the Associated Press to call the race. Zohran Mamdani, a 34-year-old democratic socialist and state assemblyman from Queens, had accomplished what many considered impossible just a year earlier: he defeated Andrew Cuomo—twice—to become New York City's 111th mayor, its first Muslim mayor, and its youngest in over a century.

Mamdani, son of famous Ugandan immigrant parents Professor Mahmood Mamdani and Mira Nair, the noted film maker of Hollywood, represents the aspirations of the new generation in the USA. His success gives a beleaguered democrats a new face, a new voice, to fight the behemoth Trump and his billions and donors to fight the ensuing New Jersey, Maryland and Virginia elections, which could be teaser for the more challenging 2026 November mid-terms where the democrats hope to retake the house of representatives. At present Congress is precariously placed in favour of the Republicans: House 220 Republican and Democrats 215,

Senate Republicans 53 and Democrats 47. 2026 is now the major battleground against Trump, with Gen Z against him in the East and West coasts, a new challenging factor in buddy billionaire Elon Musk who could cut into Trump's popularity and GOP vote bank. Zohran's margin was decisive. Mamdani defeated Cuomo, who ran as an independent after losing the Democratic primary, by approximately 9 points, with Republican Curtis Sliwa trailing far behind. More than 2 million votes were cast, the highest turnout since 1969, suggesting that Mamdani's message resonated far beyond progressive base. Mamdani's victory wasn't accidental—it was methodical, strategic, and built on a foundation that many establishment Democrats have forgotten: talking to voters about what actually matters to them. In a city where the median rent for a onebedroom apartment exceeds \$3,500 and where working families struggle to afford basic necessities, Mamdani stayed laserfocused on one issue: making New York affordable. His platform included rent freezes on rent-stabilized units, free bus

service, universal childcare, city-owned grocery stores, and 200,000 new affordable housing units. It was ambitious, yes, but it spoke directly to the lived experiences of millions of New Yorkers. His campaign announcement exemplified this focus. On January 1, 2025, Mamdani participated in the annual polar plunge at Coney Island, standing in frigid water to declare: "I'm freezing... your rent as the next mayor of New York City." The video went viral, capturing both his message and his personality in one memorable moment. Mamdani understood something that many established politicians miss: the power of authentic, creative digital communication. His campaign produced smart, funny videos that frequently went viral, reaching voters where they actually are—on their phones. One memorable video showed him eating halal food on a cold night near Wall Street, explaining how the city's arcane permit system inflated prices for what should be cheap street food. These weren't slick, expensive productions. They were real, relatable, and effective. While Cuomo had backing from billionaires and corporate

PACs raising over \$40 million— Mamdani mobilized tens of thousands of volunteers. This grassroots energy, particularly among young voters, created a ground game that money couldn't match. Exit polls showed voters under 45 favored Mamdani over Cuomo by 43 points. Despite predictions that Mamdani's progressive platform would only appeal to a narrow slice of voters, NBC News exit polling revealed he won across all racial demographicswhite, Black, Latino, Asian, and other races all backed his candidacy. This wasn't a victory of one demographic group; it was a broad coalition unified by economic concerns. Mamdani's victory speech struck a defiant tone against President Trump, declaring "In this moment of political darkness, New York will be the light." But rhetoric aside, he faces formidable obstacles. To implement his most ambitious proposals-particularly tax increases on corporations and wealthy individuals earning over \$1 million annually— Mamdani needs approval from Governor Kathy Hochul and the state legislature. While

Hochul eventually endorsed him, many Democratic leaders in Albany were not enthusiastic supporters. Uniting these leaders will be his first major test. His biggest challenge is to bring Bill Clinton, the most popular Democrat president on board, who was Cumo's god father. Obama may pitch in while Clinton may not, but Obama matters today more than Clinton. Many City Council members didn't eagerly line up behind Mamdani during the campaign. Building working relationships with them while maintaining his progressive vision will require political skill and compromise—qualities not fully tested during his campaign. Critics have questioned whether Mamdani's proposals are financially viable. He plans to raise corporate tax rates to match neighboring New Jersey's and impose a 2% flat tax on incomes over \$1 million. But will these revenue sources be sufficient? And will wealthy residents and corporations simply leave, shrinking the tax base further? President Trump has already threatened to withhold federal funding to New York City under a Mamdani administration, calling him a "communist."

Five Arrested in Rs.91 Lakh Job Scam – Vizag Police Bust Fake Employment Racket

Visakhapatnam, Nov 5 (Pen Power): Gajuwaka police arrested five persons for duping a young couple of Rs.91.36 lakh under the pretext of providing permanent jobs in Visakhapatnam Steel Plant. The accused — Machha Sajini (37), Machha Venkata Narayana (40), Seerapu Shanmukh Aditya Kumar (20), Seerapu Ram Prasad (24), and Seerapu Anita (41) — allegedly collected money through PhonePe, bank transfers, and cash from complainant Sinagam Alekhya (24) and her husband Vinayaka Rao, who had filed a complaint on September 30, 2025. Police said Sajini and her husband promised jobs if the victims paid Rs.50 lakh each, assuring both employment and interest on the money. After collecting Rs.91.36 lakh between April 2023 and August 2024, the accused switched off their phones and went into hiding. Investigation revealed they used the funds to buy houses and lorry trailers in Sriharipuram and Pedagantyada. All five were arrested on November 4, and their mobile phones were seized. Eight more suspects are yet to be caught. Inspector E. Partha Sarathi warned that demanding money for government jobs is illegal and urged the public to report such frauds immediately.

Changes Needed in NH-65 Expansion Plans: Elevated Corridor Proposed as Best Solution



Machilipatnam, Nov 5 (Pen Power): NTR and Krishna district collectors Dr. G. Lakshmi Sha and D.K. Balaji have suggested modifications to the proposed expansion of NH-65 from Vijayawada to Machilipatnam into a six-lane highway. During a review meeting held at the NTR District Collectorate with public representatives, NHAI, and Metro Rail officials, Dr. Lakshmi Sha instructed officials to prepare three alternative designs in coordination with Metro authorities. She noted that the current design doesn't address the heavy traffic congestion between Benz Circle and Chinagirira and emphasized the need for more vehicle underpasses. Collector D.K. Balaji said that

an elevated corridor would be the best solution to tackle the growing traffic, especially with the expected increase from suburban and port-related vehicles. He also pointed out drainage issues and advised against linking NH-65 expansion with ORR and Metro projects.

MLAs Gadde Rammohan, Bode Prasad, and Varl Kumar Raja urged connecting NH-65 with NH-16 through three new link roads, increasing underpasses, installing streetlights, and resolving waterlogging problems at certain points. Senior district officials, NHAI PD Vidyasagar, Metro Rail representatives, and other department officers attended the meeting.

Collector Orders Fast Completion of Jonnada Flyover Works
