# ED IN BLAST NEAR



- Car with people exploded at Traffic Signal - "Condolences To Those Who Have Lost

Their Loved Ones In Delhi Blast": PM

New Delhi: Thirteen people were killed and 24 injured after a high-intensity explosion ripped through a car with passengers this evening near Delhi's historic Red Fort, one of India's most high-profile spots. The blast took place in a Hyundai i20 car at 6.52 near the Red Fort Metro Station, leaving mangled bod-

ies and wrecked cars scattered in the busy area. "It was a very powerful explosion," said sources in the Delhi Police. "The blast took place in a slow-moving vehicle that stopped at the Red Fort traffic signal. There were occupants in the car. The blast damaged cars nearby," Delhi Police

Golcha told reporters. The explosion damaged nine vehicles. The Hyundai i20 car was registered in the name of one Nadeem and had a Haryana registration number. India's premier terror probe agency, the National Investigation Agency (NIA), and the National Security Guard have joined the investigations.



## 2,900 kg Explosives Found At 2 **Houses Of J&K Doctor In Faridabad**



Faridabad: Just a day after 350 kg of explosives and several arms and ammunition were

seized from a rented accommodation, 2,563 kg of suspected explosives were recovered from

another house in Haryana's Faridabad. Both the houses were rented by Dr Mujammil Shakeel, a doctor from Jammu and Kashmir's Pulwama who has emerged as a key link in a "white-collar" terrorist ecosystem involving radicalised professionals. As per the initial police investigation, the recovered substance is likely ammonium nitrate. The Faridabad and Jammu and Kashmir Police have been conducting raids at this house since this morning.

Shakeel, who works at Al Falah Medical College and Hospital in Faridabad, was arrested in the case recently. Al Falah University in Faridabad's Dhoj, around 45 km from Delhi, is privately run and recognised by the University Grants Commission (UGC). On Sunday, the officials recovered 350 kgs of explosives, 20 timers, assault rifles, handguns and ammunition from a room that Shakeel had been renting in Dhoj for the past three and a half years.

#### Poll-Bound Bihar On High Alert After Delhi Red Fort Blast Kills 13

Poll-bound Bihar was put on high alert after a powerful explosion near the Red Fort in Delhi killed thirteen people and injured over twenty people. Security across the state, already beefed-up for the final phase of assembly polls on November 11, has been intensified.

## 'NO ONE SUSPECTS DOCTORS'

The Terror Plot Behind Faridabad Explosives Haul

Faridabad: The two doctors linked to the 2,900-kg haul of bomb-making material in Faridabad near Delhi were in regular touch with their handlers in Kashmir and were awaiting details of their target, top sources in the security establishment have saidDr Adeel and Dr Muzammil have told the police during interrogation that they were chosen for the task because the handlers believed "no one would suspect doctors in Delhi NCR", the sources said. The doctors



were told to wait for details regarding their target. The conspiracy, the sources said, was hatched in Pakistan, and the directions were coming through handlers in Kashmir.

Police said this terror module was linked to Jaish-e-Mohammad and Ansar Ghazwat-ul-Hind. The operation has led to the arrest of key operatives and recovery of a massive cache of arms, ammunition and explosives, during coordinated searches in J&K and other states. The doctors' interrogation suggests that creating communal disturbance in Delhi NCR was also part of the plan, the sources said, adding that the target could have been any-

#### 227 specialists posted to strengthen secondary hosps across AP

Viiavawada: To address the shortage of specialist doctors in secondary-level hospitals that form a critical part of the government healthcare network, the State health department has deployed 227 postgraduate doctors across 142 secondary hospitals in the State. According to officials, the postings were finalized through counselling across 12 specialties, including gynecology, general medicine, general surgery, anesthesia, pediatrics, orthopedics, radiology, ophthal-

mology, dermatology,

ENT, and pathology.

Secondary health director Kevin Chakradhar Babu and public health director Dr. Padmavati briefed health minister Y Satyakumar Yadav on the hospital-wise and subjectwise distribution of newly posted specialists. Of the total appointments, 155 doctors have been assigned to 100 Community Health Centers (CHCs), 60 to 33 area hospitals, 10 to seven district hospitals, and two to two MCH hospitals. The Gudur Area Hospital has received the highest allocation, with four specialists, including a pediatrician, radiologist, dermatologist, and pathologist. Minister expressed satisfaction over the recruitment drive, saying the appointments mark a major step toward improving specialist availability and service quality in government hospitals. Out of 257 in-service PHC doctors who completed their postgraduate studies in 2022–23, 227 have been posted to secondary hospitals, while the remaining 30 doctors have been designated as tutors in Directorate of Medical Education (DME) institutions due to the absence of suitable vacancies.

## Tirumala prasadam scandal YSRCPs alleged role in fraudulent ghee supply to TTD, CBI investigates: Kommareddy Pattabhiram

## **Today's Criticism of Multiple Voices**

Criticism has been stagnant for the past fifteen years, lacking new theories and in-depth analysis. He said that the 'methodical' criticism that stretched from Kattamanchi to Tripuraneni has stopped, and today's critics are only revolving around four words: 'object, language, expression and sculpture'. While there is truth in some of the concerns expressed in the article, it is a mistake to dismiss the contemporary field of criticism as completely 'without standards'. In fact, today's Telugu criticism does not suffer from 'lack of standards'; it has evolved from 'single standard' towards 'multiple standards'. This is not a weakness, but a sign of maturity that reflects the complexity of modern society and the diversity of literature.

The main allegation in the original article that 'there are no new theories' is a most astonishing argument. 'New theory' does not fall from the sky; it means applying new philosophical thoughts and social science theories from around the world to our literature and building our own critical methods. The work that has been done and is being done in that direction in the last fifteen years cannot be ignored. Existential criticism has spread during this period. In this category, Dalit, feminist, BC and regionalist criticisms have not stopped as mere 'object' criticism. They are constructing their own aesthetics. Sangisetty Srinivas's book 'Savaru' on Muslim literature, Katyayani Vidmahe's 'Neeli Ragam' essays in Kolimi Patrika, Dattayya Attem's book 'Telangana B.C. Vada Sahityam', Surya Dhananjay's book 'Kakoti' are among these categories. Adluru Raghuramaraju's book 'Vaddera Chandidas: Darshanamu Sahityam' discusses the novels of Vaddera Chandidas from the perspective of 'Writing, Reading and Criticism'. G. Aruna Kumari's book 'Telugu Kavitam Bhavishyaddarshanam' is written from the perspective of futurology. Olga's book 'Santulita' is written from a multidisciplinary perspective. Y. Raghu's book 'Samanvaya' is written from a descriptive criticism perspective... Jilukara Srinivas and Pasunuri Ravinder have introduced new methods like the New Dalit Criticism. All these are applications and constructions of 'new theories'. Therefore, saying 'nothing is happening' is denying the reality before our eyes. The original article expects the critic to play the role of 'judge'. But in modern criticism, the role of 'analyst' or 'commentator' has strengthened in place of the role of 'judge'. This is not a decline, but an evolution. In the past, people like Kattamanchi gave judgments that 'poetry should be like this'. It was the historical necessity of that time. Today's criticism analyzes a work 'why is it like this', 'what is its socio-historical context', 'what is the ideology behind it'. Rather than giving a 'judgment', the goal of today's criticism is to 'provide the reader with tools to understand that work from multiple angles'. Gopalaiah is disappointed that 'we are only looking at analysis' in today's criticism. But 'evaluation' is an integral part of that 'analysis' itself.

Gopalayya is wrong to dismiss criticism as not being a criticism if it is written in four words: 'object, language, expression, sculpture'. Criticism of any period revolves around these. The problem is not in those words, but in the way they are analyzed. For example, taking the first of the things mentioned by Gopalayya, 'object' – as in the past, today's critical writing is not limited to 'what is the object'. The main question of today's criticism is 'from whose perspective is that object being viewed'. For example, Marxist criticism analyzes the same object 'family' from the perspective of 'class' relations; feminist criticism from the perspective of 'gender' discrimination and 'patriarchy'; and psychological criticism from the perspective of 'internal' conflicts. Today's critical writing does not simply examine whether 'language' is 'simple or complex', 'textual or pragmatic'. It examines the 'power relations' and 'dominant ideology' behind language. This is called Discourse Analysis. Never before has there been such a deep discussion on 'language' and 'dialectal politics' as the regional existentialist criticism of Telangana and Rayalaseema. Isn't it an important aspect of today's criticism to analyze how the language of some regions and groups has been suppressed in the name of a standard language? Now, when it comes to 'expression' and 'sculpture' - after the advent of postmodernist methods, the analysis of 'sculpture' has completely changed. It is not a calculation of ornaments and a balance of rhymes like in the past. Sculpture is being analyzed with new tools like narrative techniques, magic realism, and intertextuality. The role of the reader has also become a part of sculpture analysis.

## Why Bihar Saw Highest Gap In Male-**Female Turnout In Phase 1 Voting**

phase of voting for the Bihar assembly polls has surpassed all records at 65.08%, much higher than the overall turnout of 57.29% in 2020. However, nothing can be said conclusively about these figures unless one analyses the respective turnouts for men and

Many believe that deletions under the Special Intensive Revision (SIR) process have contributed to the increased turnout. However, this is a misconception. That is because at 7.42 crore, the total size of the electorate has increased, too, up from 7.36 crore in 2020. A high turnout in the first phase this time shows that the absolute number of votes polled is higher by 35 lakh from that in 2020. Hence, even without SIR, the turnout would likely have increased by around 4%.

#### A Significant Gap Between Male And Female Voters

The male-female dynamic is important here. According to reports, the female turnout this time was 69.04%, significantly higher than the male turnout of 61.56%. This gap of 7.5 percentage points underlines a unique reality of Bihar. For the last three elections, women have outnumbered men by three to seven percentage points in terms of voter turnouts. Though official Election Commission data is awaited, the trend has only grown stronger.

Why Women Outvote Men In October 2005, when Nitish Kumar won the election in Bihar, fewer women (2.6 percentage points less than men) came out to vote. However, later, thanks to marked improvements in law and order

women-centric schemes, such as distribution of bicycles, reservation in jobs and local bodies, Jeevika Didi programme, and liquor bans, more women started coming out to vote. In 2010, the female turnout was higher than that of men by 3.35 percentage points. In 2015, this gap widened to 7.2 percentage points, though in 2020, it dropped to 5.3 percentage points. The 7.5 percentage point-gap in the first phase of polling this time simply reinforces this trend. High women's turnout in Bihar can also be explained by the state's socioeconomic situation. As men migrate to other states and cities in search of work, they often miss out on voting.

#### How JD(U) Has Benefited

In any case, the trend has been helpful for the National Democratic Alliance (NDA) especially the Janata Dal (United). Both in 2010 and 2020, the NDA won the elections on the back of women. The JD(U) has a high strike rate of 70-90% in seats where women outvote men: 37 out of the 43 seats it won in 2020, 61 out of 71 in 2015, and 79 out of 115 in 2010. In 167 out of the total 243 seats where women outvoted men in 2020, as many as 99 were won by the JD(U). In contrast, the Mahagathbandhan won 49% of the 76 seats where men's turnout was higher than women's. In fact, in 2020, women played a huge role in the NDA's close win against the Mahagathbandhan. While the NDA led by 1% amongst women, the Mahagathbandhan had a 2% lead amongst men.

The Trends This Year According to the VoteVibe

tracker, in the beginning of October this year, the NDA was leading by 6% amongst women, while the Mahagathbandhan was ahead by 2% amongst men. Among young male voters, the Mahagathbandhan is ahead by 7%, though the Jan Suraaj Party (JSP) is also fragmenting votes, according to an analysis by Ascendia Strategies. Thus, while the Mahagathbandhan is expected to get 41% of the male votes, the NDA may get 34%, and the JSP 18%. On the other hand, among young female voters, the NDA enjoys a lead of 14%. So, while it is expected to bag 48% of the female vote, the Mahagathbandhan may get 34%, and the JSP 8%. The JSP's announcement that it'd enforce prohibition if elected is adding to the confusion among women voters. Even so, the point is that in absolute numbers, the size of the female elec-

that of men. However, according to reports, both men and women voters were equal in number in the first phase: 1.22 crore. The number of votes cast by women has doubled during the 2005-2020 period, from 1.04 crore to 2.08 crore, while that of men has grown 1.5 times, from 1.41 crore to 2.11 crore. The total number of votes cast by men in March 2005 was 1.41 crore, compared to 1.04 crore for women - a lead of 37 lakh for men. Similarly, the number of votes cast by men in 2020 was 2.11 crore against 2.08 crore for women - a lead of 3 lakh for men. The share of votes cast by women in Bihar elections has increased from 42.48% in 2005 to 49.62% in 2020. In sum, the 7.5 percentage point gap in male and female turnouts indicates that the Mahila Rozgar Yojana under the Nitish Kumar government has been effective. Many are calling this contest a "das-hazariya" elec-

tion, referring to the Rs 10,000 sum given under the women's employment scheme. In some ways, thus, Nitish Kumar has been successful in creating a caste-neutral female vote bank. According to the VoteVibe tracker, 58% of women have used the money they've received to start small businesses. Many also hope that they may receive Rs 2 lakh after six months. The identity of Jeevika Didis, too, which is independent of their roles as wives or daughters, appears to have had a significant impact among women. The rising trend of women's turnout in Bihar indicates an important shift in the state's politics. Women's empowerment schemes, improved law and order, and increased political awareness among women have made them a decisive voter group. The results of the 2025 elections will determine whether this trend continues and which alliance benefits most from this shift.



# What Mamdani Can Teach The Congress - And Rahul Gandhi

"The working people of New York have been told by the wealthy and the well-connected that power does not belong in their hands... And yet, over the last 12 months, you have dared to reach for something greater. Tonight, against all odds, we have grasped it. The future is in our hands. My friends, we have toppled a political dynasty." These words, by now, have been heard by millions across the globe. They have leapt out of newspapers, televisions, and, perhaps most potently, Instagram. All this has happened because Zohran Mamdani, a 34-year-old migrant Muslim, a self-declared democratic socialist of mixed parentage - a man who might easily have been consigned to the margins of contemporary political economy - has become the new mayor of New York City. Mamdani's success has signalled a system reset: a toppling of a political dynasty that sought legitimacy from the common people even as it worked to de-power them. Who was Mamdani fighting? On the road to New York's City Hall, he met with intense opposition from the business and financial community. Mamdani's progressive platform - freezing rent prices, taxing the city's wealthiest one per cent, and demanding corporate accountability alarmed traditional Democratic donors and real estate magnates. Over 20 billionaires spent millions to back his opponents, including former Governor Andrew Cuomo. Figures like Michael Bloomberg, Bill Ackman, and Ronald Lauder funded an unprecedented campaign against him, terrified that his economic agenda would drive away corporations and

destabilise the real estate mar-

And yet, he won. A 2019 meeting of right-wing donors from Peter Thiel to J.D. Vance and Tucker Carlson - had sought to make the MAGA movement an enduring political machine. Mamdani confronted a similar corporate-political nexus in New York and beat it. He re-centred democracy around people rather than profit. The lesson from Mamdani is simple: dismantling this usurpation of people's power must be done by returning to the people. If 104,000 volunteers could make 4.4 million calls for Mamdani, what can the Congress under Rahul Gandhi conjure in India? But, like Mamdani's Democrats, Rahul Gandhi has inherited a Congress that resists change -

comfortable in its proximity to

power, even when out of office.

Perpetual Inaction For decades, Congress's reflex after every electoral defeat has been to form a committee. The Committee Raj has become its comfort zone - a bureaucratic ritual that replaces action with analysis. In May 2022, Sonia Gandhi, who was then the party's interim president, established a high-profile Empowered Action Group (EAG) to address Congress's political challenges ahead of the 2024 elections. However, there is no record of the EAG holding deliberations between 2022 and 2024. Nor is there any proof of it formulating a strategy for the 18th Lok Sabha polls. After the losses in Rajasthan and Chhattisgarh in 2023, internal reports were filed, but not discussed. At 24 Akbar Road, vol-

**Movement Over Machinery** 

Mamdani's campaign spoke in the language of the streets, not the boardroom. His visual identity - a hand-lettered logo inspired by vintage Bollywood posters, painted in MetroCard yellow and New York Mets blue - made a Muslim-South Asian face feel inseparable from New York's political imagination. Every choice was deliberate. His videos appeared in English, Urdu, Spanish, Hindi, Bangla, and Arabic. He interviewed halal-cart vendors about "halalflation", canvassed subway riders, and turned daily posts into collective storytelling. It worked because it felt real. Congress's branding, in contrast, remains sterile. When was the last time a Congress campaign stopped anyone mid-scroll? Rahul Gandhi tried to infuse freshness through the Bharat Jodo Yatra, an ambitious cross-country walk blending activism and outreach. He met farmers, artisans, and workers. He filmed conversations, livestreamed encounters, and opened the party to empathy. But what Mamdani achieved through participation, Congress tried to simulate through performance. The result? Motion without movement.

The Authenticity Deficit

Mamdani's strength was not charisma alone - it was also his credibility. His volunteers spent days and nights knocking on doors, having real conversations with everyday people. That human infrastruc-



ture made Mamdani and the promise he symbolised believable. Congress, meanwhile, suffers from a chronic authenticity deficit. The party's funding networks remain intertwined with the very business interests it critiques. The average voter hears the rhetoric but sees the contradiction. Mamdani won despite opposition from the Democratic establishment. Rahul Gandhi, in contrast, is surrounded by his own establishment - one that muffles every reform instinct in procedural layers. When Gandhi speaks of empowering the poor, the message is often lost behind the family name and the party's inertia. Voters hear conviction but see privilege. The most poignant moment of Mamdani's victory came when he quoted Jawaharlal Nehru's Tryst with Destiny: "A moment comes but rarely in history when we step out from the old to the new..." An Indian-origin politician in New York has kept Nehru's democratic soul alive more vividly than the Congress in India. Mamdani's agenda rent freezes, free public trans-

port, universal childcare, taxing the rich - is Nehruvian in spirit: economic justice as the foundation of political freedom. The Congress of today invokes Nehru, but no longer imagines like him. His legacy is defended, not advanced.

Mamdani mobilised a generation dismissed as disenchanted. His campaign saw New York's highest voter turnout since 1969, driven by those under 45. Rahul Gandhi has attempted to speak to India's young, often with sincerity and intellectual depth. Yet, such interventions, however well-crafted, remain isolated performances. They do not convert into a participatory movement because the Congress ecosystem centralises power. India's principal opposition needs what Mamdani offered New Yorkers - a rupture with business-asusual politics. The Congress must stop narrating nostalgia and start reclaiming moral imagination. Because in the end, as Mamdani reminded the world, democracy survives only when people, not corporations, hold power in their hands.


