#### Continue **Intensively** (DGP) Harish Kumar Gupta stated that

stringent measures are being taken to make Andhra Pradesh a Maoist-free state within the deadline set by the Central Government. In the wake of the recent encounter

between Maoists and police in Maredumilli, the DGP toured Rampachodavaram in Alluri Sitharama Raju district on Thursday. Addressing the media, he revealed that the

Andhra Pradesh Police Department achieved significant success in the ongoing 'Operation Sambhay,' conducted in the Maredumilli forest region over the past two

The DGP conducted an aerial survey of the operation zone before speaking to reporters. He disclosed that 13 Maoists were killed during the exchange of fire, including top leaders such as Hidma and Tech Shankar. He also announced that 50 Maoists had been arrested across the state as part of this crackdown

DGP Gupta said the success of the operation was the result of coordinated efforts by ASR district police and the State Intelligence Department. Police recovered large quantities of weapons, ammunition, explosives, and Maoist propaganda material from the encounter site. These seizures dealt a major blow to the Maoist

organization, he noted. Recalling the major encounter that took place in June, the DGP said police had earlier appealed to Maoists to surrender, but they chose not to take that path. He once again

urged them to give up violence and join the mainstream. The government and the police department are ready to help them return to normal life, he assured.

He reiterated that the ultimate goal of the Andhra Pradesh Police is to completely eliminate Maoist influence in the state. Achieving this will ensure smooth implementation of development activities without disruptions, he added.

DGP Gupta thanked

the police personnel involved in the operation and the public who provided vital information. He emphasized that Operation Sambhav is still ongoing and will continue with greater intensity. Anyone supporting Maoist ideology will be brought under control, he warned. He also clarified that Maoist leaders Dev Ji and Malla Rajareddy are not in police custody. The DGP said the success of this operation stands as proof of the police department's strong commitment to strengthening state security. The fight against Maoism will continue as part of a long-term strategy to secure the state's future and ensure uninterrupted development.

## **CM** conducts teleconference for farmer welfare programs



From Our Staff Reporter Amaravati, Nov., 20: The state government is undertaking several programs to make cultivation profitable through radical changes in the agricultural sector. As part of this, it has focused on programs that benefit farmers through the five principles. In this order, programs will be undertaken from the 24th of this month. From the 24th to the 29th, public representatives and officials will visit every farmer's house. Workshops will be held within the scope of the Rythu Seva Kendras on December 3. Agriculture-related sectors and marketing department officials will participate in this program. Chief Minister Chandrababu held a teleconference with 10,000 people, including officials of agriculture and allied sectors as well as staff of Rythu Seva Kendras on Thursday. In the teleconference, he directed the respective departments on the issue of educating farmers on the five principles announced by the Chief Minister on the changes to be brought in the cultivation system for the welfare of the food givers. To this extent, the schedule of programs to be organized at the field level in the state has been announced. Programs will be organized under the name 'Meekosam Raithanna' for this

program. Staff working in the

Rythu Seva Kendras will play

a key role in this program. Speaking on the occasion, Chief Minister Chandrababu Naidu said in a teleconference, "For the last 7 months, we have been taking farmers and agriculture forward. We have already deposited Rs. 14,000 in two installments to more than 46.50 lakh farmers under Annadata Sukhibhav and PM Kisan. Atotal of Rs. 6,310 crore has been paid to farmers in two installments. We are giving high priority to drip irrigation. We have also taken up the Polam Kemandi program. Along with these, we have announced five principles to further develop agriculture and benefit the farmers. We have taken up the five principles policy with the topics of water security, demand-based crops, agritech, food processing, and government support. These five principles should be made aware not only to every farmer but also to the farmer's family members. Along with farmers, dairy farmers, poultry, sheep farmers, aqua, horticulture and sericulture farmers should be made aware.

This program will be implemented by the staff of the Rythu Seva Kendras. It should be taken up from the front. Along with this, workshops should also be organized. An action plan should be made in every farmer ser-

vice center," he said. He said that the steps

through modern methods should be explained door to door. He revealed that only scientific farming can benefit the farmers and that natural farming is being further encouraged. The Chief Minister said that this will improve health along with soil protection. He said that they are already doing traceability along with certification for the respective products and that natural farming products should be further promoted in the farmers' markets. He said that he had also examined natural farming in Kadapa and that the farmers who cultivate it are very satisfied. He said that the price of fertilizers at Gromore centers is lower than that of private fertilizer shops.

"The investment costs for farmers should be reduced.

taken by the government to Setting up food processing add more value to crops units will benefit the products. We should know directly what crops the farmers have cultivated and what kind of help they need. The losses caused by the use of pesticides in cultivation should be explained to the farmers in a clear way. We have been able to fill the reservoirs through complete water management. #### Digital arrest scam:

#### **Tirupati police arrest eight for** cheating elderly citizen of Rs.80 lakh

Tirupati, Nov., 20: The Tirupati police arrested eight persons, believed to be mem bers of an inter-State cyber criminal gang, for allegedly swindling senior citizens on the pretext of 'digital arrest'. According to the police, the accused made a video call to a 65-year-old resident of Tirupati. Identifying themselves as CBI officials from Mumbai, they threatened to arrest him, citing his 'involvement' in a Rs.583-crore money laundering case. Assuring to conduct the inquiry through virtual mode, the senior citizen was fooled into transferring Rs.80 lakh into suspected mule accounts. After the accused stopped responding, the victim complained to the cyber wing of the Tirupati police. Superintendent of Police L. Subbarayudu formed a special team under the Sub Divisional Police Officer (Tirupati) to probe the case, who found that the money had initially been transferred into two accounts and from there to several accounts in fourteen States. The trail led to several users of gaming applications.

Dande Kranti Kumar and Nimmala Pavan Kumar of Anantapur, Mane Koti Babu and G. Gautam of Hyderabad, P. Srinivas of Rajamahendravaram were accused of the



Kodela Sivasankar adn N. Prashanth Reddy of Ballari in Karnataka. All of them were arrested and the Rs.2.5 lakh found in two joint accounts was freezed. The probe showed that the prime accused, Koti Babu, went to Cambodia to get trained in cybercrimes for 24 days, got in touch with Daniel of Haryana and Teon of China and also a suspected criminal network, identified simply as 'D'.

Otherwise, they will be either caught or neutarlised", said Mr. Harish Kumar Gupta in an interaction with newsmen in Rampachodavaram in Alluri Sitarama Raju district. Referring to Kintakuru encounter, in which three Maoists were killed in June, Mr. Harish Kumar Gupta stated; "We have been asking the Maoists to surrender since Kintakuru encounter. The Centre has set March 2026 as a deadline to declare Andhra Pradesh free from left-wing extremism. All the security forces (deployed in Andhra

Pradesh) are on that task." In June encounter in Maredumilli agency in Alluri Sitarama Raju district, three Maoists including Gajarla Ravi alias Uday, CPI (Maoist) central committee member and secretary of Andhra Odisha Border Special Zonal Committee (AO BSZC), Raavi Venkata Chaitanya alias Aruna, were killed. "At least 13 Maoists, including the most wanted Madvi Hidma, have been killed in the two encounters within two days in Maredumilli agency durthe Operation

Sambhav. There is no place for violence in Andhra Pradesh", said Mr. Harish Kumar Gupta. Jagan Mohan appears before CBI special court in Hyderabad in long-pending DA case



Hyderabad, Nov., 20: Former Chief Minister of Andhra Pradesh, Y.S. Jagan Mohan Reddy, appeared before a special court for CBI cases in Nampally, Hyderabad, on Thursday, complying with the Court's recent directive that he must ensure his personal appearance for the hearing in the long-pending disproportionate assets (DA) case. The court order came after the withdrawal of Mr. Reddy's plea seeking exemption from personal appearance, a request which was allegedly opposed by the CBI. The Nampally Court has scheduled the next hearing in the cases involving Mr. Reddy for November 28, while the discharge petition filed by him remains pending.

The DA case, which dates back over a decade, pertains to alleged quid pro quo investments made by private firms and individual investors in Mr. Reddy's companies, reportedly in exchange for government favours during the tenure of his father, the late Y.S. Rajasekhara Reddy, as Andhra Pradesh Chief Minister.

## Is it revenge? Is it a dictatorial decision?

The death sentence of former Bangladesh Prime Minister Sheikh Hasina may carry the weight of the legal process. But there is a stench of an undetected act of political revenge lurking in it. On the one hand, the interim Bangladesh government led by Mohammad Yunus is praising itself for its historic verdict and the deep scrutiny it has received, while appealing to the public to remain calm during this time. However, the political unrest that has erupted across Bangladesh is exposing the deep cracks in the mistakes it has made so far. Hasina is the daughter of the freedom fighter Sheikh Mujibur Rahman. Her closest confidant, former Bangladesh Home Minister Asaduzzaman Khan, was also sentenced to death. Bangladesh is pressing for the extradition of both of them. Bangladesh is trying to approach Interpol as India is reluctant to do so. Although Hasina does not want to return to Bangladesh from India, she is forced to go to the gallows when India unexpectedly expels her.

She criticizes the tribunal's verdict on the unelected caretaker government as a political vendetta and a unilateral decision that did not allow her arguments to be heard. India is right to ignore Bangladesh's request to send Hasina back to their country. Because India argues that it will have to think only when a legally elected and constitutional government is formed. Elections are due in Bangladesh in February 2026. Hasina's Awami League was ousted from the caretaker government there, leaving no room for her. Hasina was found guilty on three main counts. She was found guilty on three counts of inciting violence during last year's studentled uprising, ordering firing, and failing to prevent violence. The tribunal sentenced her to death in two of the three counts, and in the third, she was sentenced to life imprisonment until she died naturally. These opportunities are further fueled in a country suffering from the turmoil of 2024. In light of the post-coup crackdown, the United Nations Human Rights Commission has officially confirmed that nearly 1,400 people have been killed in Bangladesh. Most of them were shot at close range. The report says that these atrocities were committed deliberately and that arbitrary arrests were carried out under a dictatorial policy. An examination of the audio recordings reveals a very humbling picture of how much the government overstepped its bounds and acted excessively. However, this verdict came at a very difficult time. Bangladesh is currently under the rule of an interim government. Its legitimacy emerged from a crisis, not from a popular vote. Dhaka has not yet achieved stability under Yunus' leadership. Bangladesh has been ablaze with protests by Hasina's supporters and Awami League activists since the verdict was issued. Protests and clashes are taking place on the streets of Dhaka.

Buses are being burned. Lathis are being broken. The absence of any of the necessary law and order and security for a country is a testament to the caretaker government. It is important to understand that the rule of law and political stability cannot be built on the foundation of revenge alone. Hasina also made some unforgivable mistakes when she was in power. She failed to stop the military from taking excessive action against the protesters. She weakened democratic institutions. She could not tolerate dissent under her watch. However, equating political revenge with the death penalty is deeply objectionable. Justice should not only light the way ahead, but should not create more dire conditions that will lead the country into instability. India is seeking restraint in these circumstances. Bilateral relations with Bangladesh could face a difficult phase. There are signs that political uncertainty in Dhaka will intensify, especially if Hasina's Awami League is not represented in the upcoming Bangladesh elections. But Bangladesh's rulers must understand that Bangladesh is not just a government, but also its people, its cultural heritage, its economic future, and its national security. If it slows down in these matters, it will only jeopardize the most crucial developments in the subcontinent. Now, the Bangladesh government must decide for itself whether the death sentence imposed on Hasina is the beginning of Bangladesh's authoritarian policies or a continuation of political revenge.

## These Are India's Options Against Sheikh Hasina's Death Sentence

crimes court - the International Crimes Tribunal - has sentenced Sheikh Hasina to death after a trial in absentia. This verdict raises many questions. Bangladesh has no legally legitimate government at present. It is an interim government that has no basis in the country's constitution. Muhammad Yunus is the Chief Advisor, with other ministers as advisors. It is this unelected government, headed by an individual who has been parachuted into power by his US backers, which has taken the decision to try Sheikh Hasina. To begin with, it is unclear how the actions of a government in the present case to suppress violent mobs by using force, whether excessive or not, can be characterised as "international crimes". The crimes attributed to her were committed within the territory of Bangladesh and had no external links. When Sheikh Hasina set up this tribunal, the logic was the involvement of the Pakistan army and its collaborators inside the country in genocidal acts against the Bangladesh population. The violent street uprising

that led to Sheikh Hasina's ouster was accompanied, as known, by widespread arson against properties and symbols associated with Mujibur Rahman, the Father of the Nation. Broadly speaking, the street revolt appeared to be not only against Sheikh Hasina but against the legacy of the Awami League that had fought for the country's independence. In the background of the assaults against the judiciary during the rioting, the forced resignations of some by the mobs, it is reasonable to suspect that the tribunal judging Sheikh Hasina was packed with compliant judges who would have given the desired judgment. The ruling clique in Dacca seems bent on barring Sheikh Hasina's party, the Awami League, from elections next year. This judgment against Sheikh Hasina delegitimises the party even though it has a very strong following in the country. Any election held without the participation of Awami League as a party would amount to disenfranchising a large part of the population. The condemnation to death of Sheikh Hasina should be seen also in the context of the hostile policies of the Yunus government towards India and the related restoration of ties with Pakistan, including the Pakistan military that was responsible for the genocide in Bangladesh. The anti-India and pro-Pakistan Jamaat-e-Islami that sided with the Pakistani army during the liberation struggle has acquired major influence in policymaking in Bangladesh, which also explains the growth of the anti-India sentiment in the country. Yunus himself has been contributing to this, which has prompted our Defence Minister to caution him about the statements that he has been making.

That Sheikh Hasina was not seen as being directly responsible for the loss of lives during the street rioting would explain why, to prevent a mob assault on her, she was flown out of the country by the country's Army Chief in an Air Force plane. If Sheikh Hasina was directly responsible for war crimes, it stands to reason that the Bangladesh Army Chief should be held accountable for aiding her escape to India. Moreover, Yunus himself is on record saying proudly at the Clinton Global Initiative in New York in September 2024 that the revolution in Bangladesh was "meticulously designed", and introduced Mahfuz Alam, the "brain" behind the student led movement to the audience. The interim government of Yunus has taken many acrimonious steps towards India. The presence of Sheikh Hasina in India is no doubt a source of discord. The issue could have been handled more wisely by the Yunus team by not consciously aggravating ties with India by unfriendly steps. Her presence here would have receded in the background and become more manageable politically for both sides if the Chief Advisor had pursued a friendly course towards India. By not doing that, the attention is now on what divides us and not what unites our interests.

The Bangladesh clique knows that India will not extradite Sheikh Hasina. This clique had sought her extradition even earlier. Now that the tribunal has given its verdict, Bangladesh is raising the ante by asking India to immediately hand Sheikh Hasina, saying New Delhi is obligated to do so under the bilateral extradition treaty, and adding that extradition is a "mandatory duty" under the existing treaty. The interim Bangladesh government law advisor has raised the pitch by saying that Bangladesh would formally write to New Delhi again to seek Sheikh Hasina's extradition, and that "if India continues to shelter such a mass murderer, it must know this would be an act of enmity against Bangladesh and its people". The spokesperson of the UN Human Rights Commission has welcomed the verdict as justice done, pointing again to the involvement of foreign interests in the ouster of Sheikh Hasina. Sheikh Hasina has, of course, rejected the ruling as politically motivated, calling the tribunal "rigged" and accusing the interim government of trying to wipe out the Awami League. She said she was willing to face charges before a fair judicial forum. Extradition is a long drawn process. We have not been able to extradite economic fugitives or terrorists from the UK, Canada or the US. Those whose extradition is sought move local courts, resort to appeals and use every means at their disposal, aided by lawyers, to prevent extradition. Our courts will

examine very carefully the evi-

dence produced by the

Bangladesh authorities, on the

basis of which the Tribunal gave its verdict. The fact that a death sentence has been pronounced will make it virtually impossible to obtain her extradition. In our Treaty of Extradition with Bangladesh, Clause 6 says that extradition may be refused if the offence for which it is requested is an offence of a political character. It can well be argued that the decisions taken to quell violent mobs that burn government property, attack the police and potentially threaten the stability and security of the country is a political responsibility that the head of the government has to bear, and hence decisions taken in the interest of the nation and society are political in nature. Article 8 of the treaty says that the extradition request can be rejected if the person concerned can satisfy the requested state that it would, having regard to all the circumstances, be unjust or oppressive to extradite him if the accusation made against him has not been made in good faith in the interests of justice.

The Ministry of External Affairs has "noted' the verdict of the "International Crimes Tribunal", stating, "As a close neighbour, India remains committed to the best interests of the people of Bangladesh, including in peace, democracy, inclusion and stability", adding that it would "engage constructively with all stakeholders" in Bangladesh. The implicit message here is that this decision is not in the larger interests of the Bangladesh people, and that India will constructively deal with developments beyond the positions taken by the interim government. We have rightly said nothing at this stage to the Tribunal's verdict, which clearly smacks of political vengeance. However, the words "constructively" and "commitment to the best interests of the people of Bangladesh" can cause some confusion because of equivocal language. A positive sounding note in the statement could have been avoided. Anyhow, it is early times and we will have occasion to make our position clearer.



#### How Hasina's Death Sentence Has Put Delhi-Dhaka Relations At Crossroads

The Bangladesh International Crimes Tribunal sentenced ousted Prime Minister Sheikh Hasina to death for crimes against humanity, which also included directing destructive force during the June 2024 student-led protests. Hasina, who resigned and fled to India, has denied the charges and claimed that the prosecution is politically motivated. However, India is not shocked by the capital punishment awarded to Hasina by the Bangladesh Tribunal. Former Home Minister Asaduzzaman Khan Kamal was also given the death penalty when he was tried in absentia, while former Inspector General of Police Chowdhury Abdullah Al-Mamun was sentenced to five years in prison. Although the United Nations and other organisations have expressed concerns about the process of their judicial prosecution, the political conviction of the Bangladesh authorities is evident, as they are not withdrawing their decision to impose capital punishment on Hasina. It is unlikely that India will return Hasina to Bangladesh. Dhaka itself is not pursuing the extradition requests stringently, as bringing the 78-yearold ousted leader back would increase internal tensions in the country, making it difficult for interim government chief Muhammad Yunus to manage, especially before the general elections

## Journalists Must Complete Accreditation Registration by November 30

Visakha, Pen Power, November 20: The registration process for granting accreditation to journalists for the year 2026-27 has begun. Deputy Director of the District Information and Public Relations Department, K. Sada Rao, has instructed that all print and electronic media representatives must complete their online registration by November 30 without fail. He stated that before applying for accreditation, every journalist must first visit the mediarelation.ap.gov.in website and fill in their personal details under the "Registration" section. After completing the personal registration, it is mandatory to upload all required documents along with complete

details related to their respective media organization. He advised journalists to complete the entire process by November 30 and start the registration immediately without any delay. The online accreditation application must be filled out and a copy should be submitted at the District Information and Public Relations Office. Local newspapers that are not empanelled should save all the required documents on a pen drive and submit them along with Xerox copies at the DIPRO office. The department has clarified that media representatives seeking accreditation must take note of this deadline and complete the registration process promptly.

## **Collector Orders Swift Action in Crimes Against SC/ST Communities**

Bapatla, Nov 20 (Pen Power Bureau): District Collector Dr. Vinod Kumar directed officials to respond immediately and ensure justice whenever atrocities or crimes occur against SC/ST communities. He chaired the district-level monitoring and vigilance committee meeting on the SC/ ST Atrocities Prevention Act at the Collectorate on Thursday. The Collector said the Act acts as a protective shield for marginalized communities and stressed strict implementation. He instructed officials to ensure timely support to victims under GO 95, including compensation and employment. Over the past two years, compensation of ?1.44 crore was provided in 152 cases, while 29 cases are under police investigation and 265 cases are pending in court. In the last three months, three cases were settled mutually, and one case resulted in conviction.

He also directed officials to prepare details of victims eligible for employment and upload case information into Google Sheets for better monitoring, emphasizing that investigations should not be delayed. The Collector also chaired a meeting of the district-level committee on Safai Karmachari welfare, stating that the government is work-



ing towards creating a society free from manual scavenging. No Safai Karmacharis were found in the district during inquiries across rural and urban bodies. He called for strengthening the financial status of panchayats and municipalities to enhance development works. Officials present included DRO G. ### **CPI Demands Judicial Probe into Fake Encounters K. Ramakrishna**



Ongole | Pen Power | November 20: CPI National Secretary K. Ramakrishna demanded a judicial inquiry by a sitting Supreme Court judge into what he termed as the fake encounters being carried out by the Union government. Speaking at a media conference held at Mallayya Lingam Bhavan, Ongole, Ramakrishna alleged that the BJP government at the Centre was running a "demonic rule in the name of Ram Rajya," targeting Maoists and innocent tribal people under the guise of encounters.

He accused the government of continuing a massacre even though Maoists had expressed willingness for peace talks. He criticised Prime Minister Narendra Modi and Union Home Minister Amit Shah, alleging that they were "killing democracy and promoting a murderous regime." ## Manchester United target is ready to join in January? Casemiro to be replaced by Brazilian Joao Gomes ahead of World Cup

Manchester: Wolverh ampton's struggles have left Manchester United with an opportunity to get their longtime target João Gomes, a report said. If the Brazilian's will to move to Old Trafford in January materialises, the contract extension offer before Casemiro will be shut, the report added. Casemiro's countryman João Gomes is rated as a cheaper alternative to Brighton's Carlos Baleba and Nottingham Forest's Elliot Anderson by United. He has been under the club's radar since 2024 as the direct successor of Casemiro. According to the latest report, the midfielder can be acquired for a sum around £40 million, Spanish portal Record claimed. Fivetime Champions League winner from Real Madrid arrived at Old Trafford for around £70 million in 2022. 33-year-old Casemiro's contract runs out at the end of the current season, but United possess an option to extend it for a further year. But, the club's



board was earlier hesitant to even consider him staying due to the fact that he remains one of the highest-paid players in the side. The midfielder has seen ups and downs during his three-year stint at Old Trafford. However, he has shown more consistency this season for Amorim's delight, and this has unlocked the door yet again for him, but only if he is willing to accept a pay cut. But if the 24-year-old Gomes agrees to come in January, United will be able to

offload another high-salaried veteran at the end of the campaign. Manchester United are in the process of getting rid of as many ageing stars as possible in the hope of improving their cost-cutting record and focusing on signing as many promising young bloods. João Gomes has played 10 games in all for the national team to date, and a string of strong shows for a major team could help him improve his chances of getting into Carlo Ancelotti's FIFA World Cup squad.

## Ustaad Bhagat Singh: Plan locked for everything

Director Harish Shankar recently confirmed that the first single from "Ustaad Bhagat Singh," starring Pawan Kalyan as a tough cop, will be released in December, officially kickstarting the film's promotions. #### 'Asian Messi' is coming to Premier League! Takefusa Kubo set to join London club in January: Report



England: Takefusa Kubo is set to end his three-year association with La Liga side Real Sociedad by joining Europa League champions Tottenham Hotspur in the January window, a report said. The former Real Madrid star, who was often called the "Asian Messi" during his formative period, will be reaching England as Sociedad are hell-bent on improving their financial situation, it said. 24-

year-old Kubo, who has also represented Mallorca, Villarreal, and Getafe in Spain, will cost Spurs •60 million, who have triggered the Japanese international's release clause, Fichajes said in a report. No major roadblocks are expected in the path of the deal's completion as Thomas Frank believes a creative winger with speedy legs is a must-have addition to his squad. However, there is a pos-

sibility that Real Sociedad will stall the deal if they get a verbal promise from potential buyers to come knocking with a bigger cheque in the summer, the report claimed. Kubo's versatility in becoming a forward and attacking midfielder when needed, and his excellent dribbling ability, could give Spurs further depth in the absences of James Maddison, Dejan Kulusevski, and Dominic Solanke. Star winger Mohammed Kudus had also suffered an injury setback recently, although it was ruled minor in nature. If not for financial reasons, the La Liga side would not have parted ways with Japan's number 20, who has managed 24 goals and 18 assists for them from 147 games. Aston Villa are also interested in Kubo, but the report labels Spurs as a clear frontrunner to secure the attacker's signature.

## T20 World Cup 2026 and IPL 2026 to only have a small gap

Kolkata: The 2026 edition of the T20 Men's World Cup, cohosted by India and Sri Lanka, will begin on 7th February with the final slated to be held a month later on March 8. What this means is a very short recovery time for players as the 2026 season of the Indian Premier League is scheduled to begin from March 15 onwards. It will mean an extremely hectic cricketing season in India with the World Cup and IPL happening back-to-back. IPL 2026 is also expected to be a longer season than usual - there are 84 league games slated for this year as compared to 74 in previous season. The date for the final has been chalked out as May 31. In previous years, IPL teams had to play 14 games in the league stage but that will now be extended to 16. More details on this are awaited. A massive boost



for the tournament is that the international players will be available for the entire season as the IPL has gotten an exclusive window in 2026. The mini-auction for IPL 2026 will be held on December 16 in Abu Dhabi. All the franchises submitted their list of retentions on November 15 with several teams making shocking decisions regarding retention, release and trade. However,


